Country Creek Subdivisions Drainage Channel Operation and Maintenance Policy

Operation and Maintenance Item #1 – Snow Removal

Operation and Maintenance Item #1 includes the snow plowing/blowing/removal of accumulated snow in the Country Creek Subdivisions Drainage Channel. The Burleigh County Highway Department requires 3 days prior notice and then will remove accumulated snow from the drainage channel. Costs included in this item are compensation rate for labor category, equipment rate, and actual time charged on a time and material basis.

Operation and Maintenance Item #2 – Erosion and Scour Repair

Operation and Maintenance Item #2 includes repairing any eroded and/or scoured areas of the Country Creek Subdivisions Drainage Channel. The Burleigh County Highway Department requires 7 days prior notice and then will begin repairs to the Drainage Channel. Costs included in this are compensation rate for labor category, equipment rate, actual time charged, materials, erosion control items, seeding, and mulching on a time and material basis.

The Landowner(s) of the Country Creek Subdivisions Drainage Channel Easement will mow the channel and remove any trees, bushes, shrubs, or debris from the channel. The easements for this project are attached to this policy.


